A Bylaw of the Village of Delia in the Province of Alberta, to authorize the rate of taxation for the year 1992.

WHEREAS the total assessment of lands, buildings, and improvements amounts to \$5,381,263.00 and


WHEREAS the rates hereinafter set are deemed necessary to provide the amounts required for Municipal, Education, Hospital, Home for the Aged, Planning, Recreation, Library, Fire Dept. and S.T.A.R.S. purposes, after making due allowance for the taxes that may reasonably be expected to remain unpaid.

NOW THEREFORE by virtue of the powers conferred upon it by the Municipal Taxation Act, the Council of the Village of Delia, duly assembled, enacts as follows:


