

**VILLAGE OF DELIA
PROVINCE OF ALBERTA
BYLAW NO. 569-08**

**A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE
PROPERTY WITHIN THE Village of Delia FOR THE 2008 TAXATION YEAR.**

Whereas, the Village of Delia has prepared and adopted detailed estimates of the municipal revenues and expenditures as required, at the council meeting held on June 10, 2008 and

Whereas, the estimated municipal expenditures and transfers set out in the budget for the Municipality of Alberta for 2008 total \$361,609.00 and

Whereas, the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$181,309.00 , and the balance of \$180,000.00 is to be raised by general municipal taxation; and

Whereas, the requisitions are:

Alberta School Foundation Fund (ASFF)	
Residential/Farmland	\$19,373.00
Non-residential & Linear	\$14,427.00
Senior Foundation	\$ 791.00; and

Whereas, the Council of the Village of Delia is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and the requisitions; and

Whereas, the Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M26.1, Revised Statutes of Alberta, 1994; and

Whereas, the assessed value of all property in the Municipality of Alberta as shown on the assessment roll is:

NOW THEREFORE under the authority of the Municipal Government Act, the Council of the Village of Delia, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Municipality of Alberta:

2. The minimum amount payable as property tax for general municipal purposes shall be \$300.00.
3. That this bylaw shall take effect on the date of the third and final reading.
