

Village of Delia
Province of Alberta
By-Law #595-12

Being a bylaw of the Village of Delia, Alberta to create the position of Assessor.

WHEREAS the *Municipal Government Act*, Chapter M-26, Revised Statutes of Alberta, 2000 as amended, Section 208 (1) (m) which decrees that the Chief Administrative Officer must ensure that assessments and assessment rolls for the municipality are prepared,

AND WHEREAS pursuant to Section 209, the Chief Administrative Officer may delegate any of his/her duties to a Designated Officer of the municipality,

AND WHEREAS pursuant to Section 210(1), a Council may, by bylaw, establish one or more positions to carry out the powers, duties or functions of a designated officer under the authority of this bylaw;

NOW THEREFORE the Council of the Village of Delia, duly assembled, enacts as follows:

Short Title

1 The short title of this Bylaw shall be the "Assessor Bylaw".

Definitions

2 In this Bylaw the following words shall be defined as:

(a) "Act" means the *Municipal Government Act*, Chapter M-26, Revised Statutes of Alberta, 2000 as amended

(b) "Assessor" shall mean a person who has the qualifications set out for assessors in the *Municipal Government Act* and who:

(i) Is designated by the Minister to carry out the duties and responsibilities of an Assessor under the *Municipal Government Act*; or

(ii) Is appointed by a municipality to the position of designated officer to carry out the duties and responsibilities of an Assessor under the *Municipal Government Act*;

and includes any person to whom duties and responsibilities are delegated by the person referred to in clause (i) and (ii)

(c) "Council" means the Council of the Village of Delia.

(d) "Designated Officer" means a person as described in Section 210 of the Municipal Government Act.

(e) "Village" means the Village of Delia or its duly authorized representatives.

Conditions

- 3 The position of Assessor is hereby established as a Designated Officer of the Village.
- 4 The Assessor will be appointed by resolution of Council.
- 5 Pursuant to the Act, Section 210 (4), the Assessor is subject to the supervision of and accountable to the Chief Administrative Officer.
- 6 The appointment of the Assessor may be revoked by Council under the provisions of the Act, Section 211.
- 7 Powers, duties and functions of the Assessor will be as prescribed by the Act in Sections 284 to Section 304 inclusive, excepting thereout Section 202, Assessment for Linear Property.
- 8 That any previous Assessor appointments are hereby rescinded.


Repeal

- 9 By-Law #589-12 is hereby repealed.


In Force

- 10 This by-law shall come into full force and effect on the day that it is finally passed by Council by giving it third and final reading and it is signed in accordance with the Act.




