2017-009 Mayor Bancroft moved that the CAO be authorized to write a letter on behalf of the Village of Delia, to the administration of the Mountain View Credit Union, in regards to their reduction in staffing and service levels at their Delia branch. Carried

RFD – Delia Municipal Library Board

RFD – PLRD / Delia School Letter of Support

RFD – Property Assessment Notices

2017-013 Deputy Mayor Rogers moved that the Village prepare and send out a separate property assessment notice to each property owner as per the MGA legislation. Carried

RFD – Village By-Election 2017

2017-014 Mayor Bancroft moved that the Village of Delia hold a by-election to fill the current council vacancy on Tuesday, May 16, 2017. Carried

2017-015 Deputy Mayor Rogers moved that CAO Nikota be appointed as Returning Officer for the by-election and that he follow all returning officer duties as prescribed by the Local Authorities Election Act, section 14. Carried

2017-016 Deputy Mayor Rogers moved that the Village does not have a separate advance voting day for the purposes of this by-election. Carried

RFD - Council Committees

2017-017 Mayor Bancroft moved that Deputy Mayor Rogers be the main contact for Drumheller & District Solid Waste, Palliser Regional Municipal Services and Canadian Badlands Board and alternate for Drumheller & District Seniors Foundation. RFD – Utility Services Bylaw 2017

2017-018 Mayor Bancroft moved to amend Schedule B of proposed Utility Services Bylaw 623-2017 to read 'Effective May 1, 2017 all properties with service connections are subject to the following:

Water Rates: Fixed operating charge of \$20 per month; Usage Rate of \$3.30 per Cubic Meter up to 20 Cubic Meters per month; Usage Rate of \$4.00 per Cubic Meter over 20 Cubic Meters per month. Garbage Collection, Landfill and Sewer Rates to remain the same. Truckfill Water Rates: Water will be charged at \$4.00 per Cubic Meter. Connection and Disconnection Fees, Deposits and Penalty sections to remain the same. Carried

2017-019 Deputy Mayor Rogers moved to amend Section 9 of proposed Utility Services Bylaw 623-2017 to read 'From the date of passing of Bylaw 623-2017 forward, an owner is responsible for all service charges, fees and other charges whether water service is connected or has been disconnected.' Further moved that Schedule B of proposed Utility Services Bylaw 623-2017 be amended by removing the note '*Note: Solid waste charges shall be applied to all utility accounts, except when the account holder advises that the property will be vacant for a period of time.' Carried

Bylaw #623-2017 Utility Services Bylaw

Deputy Mayor Rogers moved first reading of bylaw 623-2017, Utility Services Bylaw. Carried
